Yorùbá Noun Ontology from Functional Perspectives

Abstract

The present shift in language analysis from theoretical and descriptive analysis to applied, adaptable and implementation design has being the practice resulting from modern Information and Communication Technology world. It is noteworthy that Awobuluyi as a renowned Yorùbá scholar have always maintained the positon that a good grammar of any language should be from functional perspectives. Eventually, Ontological annotation as a modern practice by which theoretical knowledge occurring in its implicit form is prepared in both human and machine readable format to aid Natural Language Processing (NLP) is an edge in development. However, the fact that Yorùbá Scholars have considered other perspectives to identify and classify Yorùbá Noun make the knowledge heterogeneous and a big challenge for machine accessibility. This study in order to meet this challenge, extracts the implicit knowledge of Yorùbá nouns being described from Awobuluyi's functional perspectives, to implements an ontology annotation model named Yorùbá Noun Ontology according to Awobuluyi (YORNOA), in an explicit, formal and machine readable format which make the knowledge available for NLP. The data for this study is the classification of Yorùbá noun as contained in Awobuluyi (1978)'s Essentials of Yorùbá Grammar and Awobuluyi (2013)'s Ekó Gírámà Yorùbá. An additional 106 Nouns were purposively selected from Modern Yorùbá Dictionary to complement the twenty three (23) concept term extracted from the original text. Methontology as proposed by Gómez-Pérez, Fernandez-Lopez, and Corcho (2004) was followed to design the annotation, and Protégé 4.5 was used to implement the model. From the implementation thirteen (13) subclasses were specified of which two (2) are contrastive, the rest were non-contrastive because the (+) value that is returned for Human nouns cannot be returned for Non- Human nouns, (-) value was returned. This study demonstrate and concludes that the knowledge issues proposed from Awobuluyi functional perspectives can be extracted and presented in the format to shore up knowledge representation for NLP activities.

Introduction

Research activities in Yorùbá studies have started over a century ago, with many publications in Yorùbá language, literature, film studies, drama, culture and social life. These research studies have fostered a measurable development in Yorùbá life in all ramifications. However, the wide gap in the area of employing Information and Communication Technology (ICT) to enhance African languages in general and with specific reference to Yorùbá Language needs to be filled. Interestingly, few individuals have responded to the clarion call of employing computational methods to analyse Yorùbá language. Research in this area includes: Yoruba text to speech conversion system (Iyanda 2014), Automated Speech Recognition (ASR) for Yorùbá Tone Systems in order to build capacity in human language (Adegbola 2006, 2008, and 2009), Machine Translations (Hassan 2009, Odoje 2010, 2017), Ifè CISRG (Computing and Intelligent Systems Research Group) in the collaborative efforts of Odéjobí, Hassan and a host of others, Yorùbá cultural knowledge-based system (Emuoyibofarhe, Adebayo, Lala, and Aremu 2015), and an Introductory work on Yorùbá Ontology development. Aina (2017). These efforts have contributed in its own ways, to the call to safe our indigenous language with the use of modern technology.

Furthermore, Scholars have presented Yorùbá nouns on different perspectives such as descriptive, morphological and so on. Some of this works includes: Abrahams (1965), Bamgbose (1965, 1990), Johnsons (1921), Awobuluyi (1978, 2008, 2011, 2013), Táíwò (2006a, 2006b), Owolabi (1976). But Awobuluyi have always maintained the positon that a good grammar of any language should be from functional perspectives. As noble as this fact is, the knowledge of core grammar even from functional perspectives is still implicit on pages of literatures and it has to be brought up and prepared for machine use. Equally, ontology models are solely dependent on annotations of the inherent knowledge of language user and of course, this is a big challenge.

Based on these background facts, there is the need for more knowledge-based models to be developed on the core grammar of Yorùbá language. Many more artificial intelligent and Natural Language Processing Techniques are still needed to enable and fast track developments. This study attempts to extract the implicit knowledge of Yorùbá nouns which are described from functional perspectives in order to delineate it from annotations that could be developed from other non-functional Scholars perspectives.

This paper designs and implements an ontology annotation model named Yorùbá Noun Ontology according to Awobuluyi (YORNOA) based on the prose narratives of Awobuluyi's work making it explicit, formal and machine readable. Some of the questions this paper seeks to answer are: What are the identifying features of a noun in Awobuluyi's view? How can we design a model based on his perspectives? What are the methods and materials employable to achieve this feat?

Literature review

The focus of this section is to examine works that are related to the objective of this study. The conceptual terms: Ontology, NLP and Yorùbá nouns as different variables of the study are examined. Consideration of these related works helps to situate this study in its proper place among the existing others.

Gruber (1993:200) defines Ontology as the "Specification of a conceptualization". When used in the context of knowledge sharing, the author admits that Ontology involves formal

specification (like a program) designed for the concepts and relationship that can exist for an agent or community of agents. This definition relates more with the usage of Ontology as set-of-concept definitions and incorporates more of Artificial Intelligence (AI) tasks. It is also employed for pragmatic activities in which Ontology definitions are more of formal vocabulary. In the field of AI, what exists is what can be represented. When declarative formalism is employed to represent the knowledge of a particular domain, the set of objects represented in that order is known as 'the universe of discourse'. The set of objects and the relationship described among them are featured in one to one representational vocabulary and are formalized into a knowledge based program as Ontology. Then knowledge sharing and reuse becomes easily accessible by queries and assertions that can be exchanged among agents. However, all these works on Ontology as a concept points to its relevance to knowledge based system (KBS) and AI.

Ontology according to Lawson (2004:2)'s etymology, is the term derived from the Greek word with "onto" meaning "being" and "logos" usually interpreted as "science", thus traditionally, 'Ontology is the science or study of being'. Lawson's meaning of the word being has two senses:

- 1. Something that is, or exist, an entity or thing; and
- 2. What it is to or to exist, what all the things that are have in common.

Then if Ontology is the study of being, it is then both (1). The study of what is or what exist, the study of entities or things, and (2) the study of what it is to be or to exist, what all the things that are have in common. Elements of ontology are: Concepts, attributes, instances relations and axioms

Pareja-Lora (2012) submits that Ontology is very useful in solving computer related integration and interoperation problems. Hence, Ontology had risen to take care of what he called 'cascaded errors' that existed when attempting to incorporate and interlink various annotation and linguistic instrument in a row.

In a nutshell, ontology is a means to an end by which existing human knowledge and conceptualization of an entity is formally represented in human cum machine readable format which web searching agents, knowledge systems, artificial intelligent systems and NLP agents can explore for further computational activities.

Uses of ontology are outlined by Noy and McGuiness (2000) as:

- Defining a common vocabulary for researchers that needed to share information in a domain; hence, Ontology enhances sharing common understanding of the structure of that information for both humans and software agents.
- Enablement of reuse of domain knowledge. Several developers can either integrate existing ontologies indicating the specific portions of interest or extend an existing Ontology to describe our domain of interest.
- Since domain assumptions underlying systems changes from time to time, Ontology makes explicit these assumptions, therefore making it easy to change over time, unlike hard-coding in which underlying assumptions are hard to find and change especially for non-programming experts. But Ontology provides flexibility to those basic underlying assumptions.

- > Ontology is also useful for separating the domain knowledge from the operational knowledge.
- Ontology makes it possible to analyse domain knowledge once a declarative specification of the terms is available.

The formal analysis of terms in a domain is mostly valuable when attempting to either reuse already existing Ontology or extending them. Ontologies are useful for maintaining interoperatability between systems for translating modelling methods, paradigms, languages and software tools. (Uschold and Gruninger (1996).

Hassan, Odejobi, Ogunfolakan and Adejuwon (2013) is the first and only attempt (as far as we know) to apply ontology into a Yorùbá concept. The work used formal concept analysis to analyse the data in Yorùbá cultural domain. The terms of Yorùbá cultural domain, such as agogo, 'gong', bàtà, 'footwear', edan ògbóni, 'symbol for ògbóni fraternity' were gathered. The combination of observation, consultation, documented materials and prototyping was used to elicit samples of antiquities of Yorùbá cultural artefact. The cultural heritage samples were designed into taxonomy and protégé was used for the implementation of the prototype.

The ontology was validated by the domain and ontology expert, but the end product of it was a software model for the development of semantic application for cultural heritage. Our research is similar in that our domain of interest is Yorùbá nouns and protégé which was used for the implementation of Yorùbá Cultural Heritage is also the editor we applied to implement Yorùbá nouns. But because of the grammatical intricacies in our domain of application, our annotation design follows methontology since this is the analysis design that is suitable for morphosyntactic data.

Eludiora (2012) noted the importance of Machine Translation (MT) on the Internet especially that the web has become a useful resources for all human activities. The work observed that the MT Services based in web are still very poor, much of the language used on the Internet is still very colloquial, incoherent, ungrammatical, and full of acronyms, abbreviations, allusions, puns and jokes. The Internet has encouraged companies and individuals to offer online versions of electronic dictionaries as translation system but which anyone using such products for translating full sentences is bound to get unsatisfactory results. For that as a reason, ontology being at the backbone of these resources makes inter-operability possible and this in effect solves the problem. The ontology resources are specifically designed to aid Natural Language Processing (NLP) activities as Resource-Based Management Techniques (RBMT).

Iyanda (2014) develops a system for generating phonemic description of sounds corresponding to a piece of Yorùbá text. Yorùbá texts were gathered from textbooks and newspapers and digitised text was recorded as speech data. The recorded speech data was then analysed and annotated using PRAAT speech software. The grapheme to phoneme (G2P) system was designed with finite state transducer (FST), using Java Formal Language to automate the package and FESTIVAL engine environment was used to implement the system. This work is an eye-opener as much as Yorùbá language is concerned. Such

application that converts Yorùbá text to speech has not been developed using these computational resources as much as we know. However, it is observed that the primary standard Yorùbá corpus was not well projected in the linguist's lenses. They were discussed in ordinary layman perspectives. This is an area where thorough interdisciplinary research comes in. Our stake is that, the phoneme set needed ontological annotations at the background, the schematic annotation of those few standard Yorùbá syllable could be formally specified within ontological perspective so that web intelligent agent can share and interoperate the resources especially nowadays that more text to speech applications are been built and they are semantic web-based. After all, the Interactive Development Environment (IDE) used was web-based.

Materials

Protégé 4.5 and its constructs, the Web Ontology Language (OWL) and the plugins are the materials employed for implementing the ontology model. Protégé is an open source, feature rich ontology development environment for the Web which makes creation, uploading, modifying, and sharing of ontologies for collaborative works easily achievable. It has a full support for the Web Ontology Language (OWL), and direct in-memory connections to description logic reasoners. With its customizable user interface one can create and edit ontologies in any compatible single workspace. Protégé 4.5 desktop can be installed on various platforms like XMaCOSX, Windows, Linux, Unix Platform, Solaris, HPUX, AIX and other JAVA enabled environment. It is distributed in the form of a ZIP file from the main Protege website, and includes the 64-bit Java Runtime Environment (JRE). So, it is not necessary to have Java pre-installed on your computer to run Protégé. Just Open your browser and go to the Protégé 4.5 web site at http://protege.cim3.net/download/old-releases/, click on the download button and after the displayed, click run. This launches the install wizard. Follow the on-screen instructions to install Protégé in your Program /Files folder on your C:drive by clicking 'Next' for pre-install screens and then install when prompted. Installation steps are documented and available on the above stated website.

The Web Ontology Language (OWL) is an international standard and semantic language for encoding and exchanging ontologies on the World Wide Web. It became a World Wide Web Consortium (W3C) Recommendation in February 2004. As such, it was designed to be compatible with the eXtensible Markup Language (XML), as well as other W3C standards for not just the World Wide Web but the Semantic Web. The emphasis on the Semantic Web is such that information could be uploaded for human to search and make queries ordinarily, but beyond this information should be given explicit meaning in some formal presentation so that machines can process it more intelligently.

Data for this Research

The data for this research is contained in Awobuluyi (1978)'s *Essentials of Yorùbá Grammar* and Awobuluyi (2013)'s *Èkó Gírámà Yorùbá*. The selection of the texts is justified for the

fact that they are straightforward description of Yorùbá language grammar from functional perspectives, the language is precise and detailed enough with simplified linguistics rudiments and quite simple to assist learners who seek to understand the core grammar of Yorùbá language. The conceptual knowledge of Yorùbá nouns was isolated and classified being the data for the design and implementation of YORNOA. The prose narratives of the book were extracted and reduced to minimal token to form the knowledge of Yorùbá nouns. The identified properties of each entity in the prose is described as a prototype of the knowledge, these properties are then modelled as the artificial representation of the entities combined to make whole of the domain. The tokens are arranged to design an intermediate representation (IR) which carries all the semantic representation of the knowledge from the texts and served as resource knowledge base. The IR can be graphical or tabular representation but the intermediate representation used for this design is tabular. This is because the refined grains of this procedure are closer to human readability than graphical since the objective of our formalism is to enable both human and machine readability. The specific relations are defined before the ontology is implemented. This paper therefore presents the designed tabular intermediate representation developed from the prose narratives from Awobuluyi's functional perspectives¹. These tabular representations form the major input data for this work.

Methodology

Generally, methodology in research is a comprehensive, integrated series of techniques or methods created upon a general systems theory which shows how a class of thought-intensive work ought to be performed. Various steps were taken to implement ontology for Yorùbá nouns using the knowledge from Awobuluyi (1978) as the data extracted forms the knowledge resource. The goal of the paper is to develop a conceptual ontology-based annotation model for Awobuluyi's description of nouns in Yorùbá language from functional perspectives. Hence, the text (Awobuluyi (1978) is purposively selected as the resources used for knowledge abstraction.

Our method of achieving this goal is highlighted below as:

- > Extraction of the knowledge of Yorùbá noun class as the data for knowledge resources.
- The knowledge extracted was defined into intermediate Representations (IRs) of the domain following methontology.
- > The classes and sub classes of Yorùbá nouns is implemented using Protégé 4.0 as the editing tool.

This study followed Corcho and Gomez-Perez (2001) and Gómez-Pérez, Fernandez-Lopez, and Corcho (2004)'s METHONTOLOGY in designing our ontological annotations. Accordingly, Pareja-Lora (2012) mentions that methontology proposes ontological development life span which relies on prototype evolved. Terms in each new version, that is the prototype is allowed to be added, changed, and removed. Pre-existing ontologies could

be reused at any possible point in time in the evolved prototype life cycle, but it must be evaluated and adapted as needed the case may be. And if reuse is not feasible, then another one has to be created afresh. The constituents found in ontology developed implemented in methontology are: concepts, relations and taxonomies.

Finally, methontology rules are expressions, usually specified with the template 'if <conditions> then<consequent>', which are widely utilized to derive knowledge in the ontology, this element consists of attribute values, relation instances, expressions and so on. For example, the following rule

if (language=Yorùbá) \land word class (Token, lexical item,) \land takes (token, Lemma, 'noun qualifier') \land then Value (Token, Category, 'Noun')

fixes the statement that the 'linguistic value category Noun of a linguistic item attribute takes a noun qualifier.' In other words, the rule above was just the expression of the statement on quote in the immediate previous sentence

METHONTOLOGY conceives every fresh ontologies with the use of a set of tabular and graphical intermediate representations. These are obtained after each of the eleven tasks for ontology conceptualization is performed. These eleven tasks are known as methontology. When these tasks are properly executed the tabular and graphical intermediate representations included in the ontology will be fully completed. Such intermediate representations allow modelling of the different components of the concepts in the domain.

The eleven tasks of METHONTOLOGY according to Pareja-Lora (2012) are the following:

- Creating the glossary of terms for the (sub)-domain being conceptualised.
- > Building the sub-classification (taxonomy) of the concepts found in the domain.
- ➤ Isolating the ad hoc (binary) relations that hold between the concepts.
- Building the concept dictionary, which stores for each concept and describing in detail, the instances, the class, the instance attributes, and the ad hoc relations.
- > Creating the individual concept ad hoc relation.
- Building each instance attribute.
- Isolating each class attribute.
- > Identifying each constant in the concept dictionary.
- Description of the formal axioms
- > Forming the rules that hold for the concepts in the (sub-) domain in question, and optionally,
- > Introducing in the ontology information about instances.

However, more of these tasks could be performed simultaneously and the representation could be encompassing. YORNOA is constructed based on these methods and it covers over the five processes namely, specification, conceptualization, formalization and implementation and maintenance. The intermediate representations derived in the conceptualization of YORNOA according to the adopted text are shown below. It features the components resulting from the application of methontology for each of the concepts, relations, instances and attributes.

Task 1-9 Designing the Glossary of terms, groups, attributes etc.

The glossary of the conceptual terms of this ontology is presented in the following tabular intermediate representation. It identifies the set of all the relevant terms of the Yorùbá noun domain being conceptualised from Awobuluyi prose narratives. Their natural language definitions are provided as well as their synonyms and acronyms, the type of term they belong to, namely, concept in Table1, groups in Table2, attributes in Table 3, Class Instance attributes in Table 4 and relations in Table 5.

Twenty three (23) concept terms were extracted to build YORNOA, Thirteen (13) of it are subclasses of Yorùbá noun of which two (2) are contrastive, that is Human vs Non- Human nouns, Count vs Mass noun such that one stands in contrasts to the other. For example, the value (+) that is returned for Human nouns cannot be returned for Non- Human nouns but (-), the rest eleven subclasses do not have such opposition.

A close observation of these tables reveals differences between the attributes in Tables 2 and 4. The former is the concept type attributes while the latter is the class instance attributes. The concept type attributes state the property and the function which the class instance attribute performs, whereas the class instance attributes state the specific instance values of the identified concept type attributes. Relations, as an ontology element, represent a type of link between concepts of the domain. The following items in Tables 5 are the relations that hold for YORNOA.

The utmost goal of this task is to provide the detailed description of all the ad hoc relations in the concept dictionary and to construct the ad hoc relation in form of entity-relationship (E-R) diagrams. Figure1 below is the E-R diagram of the identified ad hoc relations in YORNOA.

Implementation of Yorùbá Noun Ontology According to Awobuluyi (YORNOA)

The procedures we follow are outlined below:

- > Start protégé. You will see the welcome to protégé dialing
- > When the Welcome to Protege dialog box appears, press the `Create New OWL
- ≻Ontology' button.
- ➤A `Create Ontology URI Wizard will appear'. Every ontology is named using a Unique Resource Identier (URI). Replace the default URI with <u>http://www.yornoa@</u> awobuluyi.com/ontologies/yornoa.owl and press `Next'.
- ➤ I save the Ontology to a file on my PC, browsing to the hard disk to save the ontology to a new file, named `yorno.owl'. Once a file is chosen then one can press `Finish'.

From these procedure, the implementation of the Yorùbá noun ontology proceeds. For YORNOA, thirteen classes were specified of which the data primer were 106 terms spread across the thirteen classes and the distribution is shown in table 6 below:

Figure 3 below shows the class hierarchy view, the annotation view and the description view of a subclass 'Demonstrative nouns' and its relationship with other classes:

Apart from the hierarchy display at the hierarchy view pane, the annotation view pane shows all the instances of the subclass Demonstrative noun, while the Description view pane shows that Demonstrative noun is a subclass of Yorùbá nouns and is at disjoint with the other subclasses like Non-Human Nouns, Place Nouns and so on. That means an item cannot be a subclass of Demonstrative noun and be a subclass of other subclasses at the same time. But some cases of homonyms are resolved in YORNO ahead.

OWL Properties Implemented for YORNOA

OWL Properties represent relationships between classes. There are two main types of properties: Object properties and Datatype properties. Object properties are relationships between two individuals. Object properties link an individual to an individual. OWL also has a third type of property called Annotation properties. Annotation properties can be used to add information (metadata, that is data about data) to classes, individuals and object/datatype properties.

Properties may be created using the `Object Properties' tab in Protégé. Figure 4 shows the buttons located in the top left hand corner of the `Object Properties' tab that are used for creating OWL properties. As can be seen from this illustration, there are buttons for creating Datatype properties, Object properties and Annotation properties. All properties created in this implementation are object properties. Figure 4 below shows examples of relations that link each type of property in the model.

Conclusions

This study has demonstrated that linguistics concepts such as Yorùbá nouns and the knowledge issues proposed from functional perspectives by Awobuluyi can be extracted from resources and modelled in both human and machine readable format to meet the emerging technological advancement. The standard techniques, principles and methods that have been in existence have it made possible to process morphosyntactic knowledge in a way that will be useful for artificial Intelligent Systems and Natural Language Processing Systems. There are many robust Yorùbá grammatical concepts that could be annotated into Ontology for knowledge sharing, inter-operability, portability and reuse. The study demonstrated that protégé as an editing tool is a useful modern tool that is available to implement Ontology for Yorùbá nouns making it accessible for the global community. Development in language accessories and its accessibility on the web can contribute to national development.
