A Socio-Semantic Analysis of Code-Switching in Nigerian Universities

Abstract

Whatever one writes or speaks today is expected to carry a message that should be understood by readers or listeners as intended. This study focuses on socio-semantics of students code-switching and the fluctuation of societal language meaning and social meaning placed on codes of two or more conventional languages and their dialects in a conversation. Some university students who maintain their cultural dialect, language, and accent are viewed as "stupid," 'inferior' or 'rudimentary' by their peers. The theoretical framework adopted for this sociosemantic study is 'conceptual analysis' as explained by Lyons (1977:109) and Saeed (2003: 34-46, 266-76), Fishman's (1972) "Domain and Topics" analysis and Labov's (2006) "Quantitative Paradigm" analysis. Data was sourced from some selected universities; students in the universities constitute the study and population while three major instruments were used: unscheduled non-participatory observation, questionnaire and motivedetermination interview. Statistical Package for Social Sciences was used to analyse the variables on the questionnaires to present the results of the data collected. A summary of the findings is presented in tables for easy comprehension aimed at drawing a valid conclusion. The analysis shows that, domains of discourse and pragmatics, language use and meaning-making have significant impact on the Nigerian university students and it was observed that the use of English language for a meaningful dialogue was almost impossible by students as result of the frequent code-switching. It also indicates that students use Nigerian languages to make meaning, due to their level of "proficiency in Nigerian languages compared to English language" and that, "they have more lexical items of their proficient language in their repertoire".

Background to the Study

The nature of whatever one writes or speaks today is expected to carry a message that should be understood by readers or listeners as intended. However, discourse involving different choices of codes for the expression of meaning and the users' ability to freely use any code by switching between predominant languages for the expression, it could become impossible for listeners to understand, yet again it could be productive if the listener is competent in both choices of codes.

This study focuses on socio-semantics, code-switching and the fluctuation of societal language meaning and social meaning placed on codes of two or more conventional languages and their dialects in a conversation (in this case Nigeria's lingua franca). Erman (2005:11-16) presenting "Issues in Code-switching: "Sociolinguistic Dimensions of Code-switching", with debates on "The Meaning of Social Meaning"; elaborated on Blom and Gumperz's three types of social constraints which presumably affects code choices of speakers for meaning making; setting, social situation, and social event. Hymes (1972) in his opinion of the choice of codes for settings explains that, social situations and social events are not kept apart, thereby making it almost impossible for speakers to avoid code-switching. This study focuses on the sociolinguistic, social and/or societal semantic aspects of code-switching that affect the society's conventional language usage for meaning-making in the users' choice of codes.

Gumperz, (1982 & 1992) cited in Erman (2005) on conversational code-switching, sees code, the dialect, and even style of switching processes as implicit ways of conveying meaning as part of the interaction between speakers within the society not minding the conventional rules violated (p12). Auer (1995), Alfonzetti (1998), and Sebba (1993) further employed conversation analysis techniques; where Auer asserts that, "any theory of conversational code-alternation is bound to fail if it does not take into account that the meaning of code-alternation depends in essential ways on its 'sequential environment'" (p.116), in other words, the meaning attached to switched codes are violated and there is need to be interpreted in relation to the preceding utterances as well as the situation/environment that demands the choice of the codes for the

conversation. For Auer, the sequential rootedness of meaning in bilingual conversation is "relatively independent" of its social meaning for the community (p.132) cited in (Erman, 2005). This means, the conventional societal meaning of a language is independent of the social usage of the same variety no matter the context.

On the other hand, social meaning of code-switching is seen by Blom and Gumperz's (1972) as a product of individual interactions to the extent that it is created and negotiated locally as well as formally in contemporary today's Nigerian university context. In other words, social meaning lies not within the act of switching itself, but in the perceived association between speech activities on the one hand, standards and individual's ability of a language choice on the other. Therefore, the central aim of this paper is the investigation of how a network of Nigerian university students, well-read bilinguals and most of all students of English Language in Nigerian universities alternate between English and other ethnic languages in everyday formal/casual conversations, and how their choice of language relates to their social identification and the relation of meaning in every conversation.

Wardhaugh (1986) asserts that, the term code can be used to refer to any kind of system that two or more people employ for communication, whether it is language and dialect or pidgins and creoles, all are codes. Alternatively, if we look at 'switching', it appears just as a movement; movement from one object to another. This means that you shift, switch or move from one code to another while speaking. This shift, switch, and movement of bilingual speakers from one code (language) to another is called "code-switching". There are numerous investigations (Shin & Milroy, 2000; Li & Milroy, 1995; Myers-Scotton, 1993) which have demonstrated the opposite and consider code-switching as an additional resource for interaction purpose, yet they have not necessarily looked at the switch socio-semantically at the formal/informal level and the effects on the standard language for meaningful expression. It is obvious that there is a well-documented and refined literature which rejects the negative claim that code-switching is a sign of laziness and deficiency in language use. Rather, it claims that bilingual speakers have the prestige of exploiting their treasure of linguistic knowledge to express meaningful thoughts and ideas (Wong, 2000).

There are different languages (codes) used by Nigerian students for interaction today, in that, most students are either bilinguals or multilingual speakers of Nigerian languages. This has led to peculiar problems for meaning-making in a context where the formal/standard expression of English language is expected of an individual. Furthermore, most Nigerian students have been in contact with at least one (1) or several other languages and/or dialects besides their Mother Tongue (L1) and Second Language (L2) (possibly Amr-Eng and BrEng), where students' environments, the nature of other ethnic groups, classrooms, social and religious gatherings, and campus settlements make switching inevitable.

Breitborde (1983) vehemently claims that the social meaning of code-switching cannot afford to ignore the societal regularities and the macro-level organization of social relationships, which arguably gives meaning to individual choices (cited in Erman, 2005), but not realizing that this hypothesis reflects communities that have basically one dominant language with multiple dialects of the same language based on the macro groups, unlike Nigeria, where we have multiple languages and dialects. Debatably, Fishman's (1965, 1972) model of domain analysis explained code-switching in urban contexts, given that it tells us very little about what the speakers accomplish as a result of alternating between available codes in their linguistic repertoire.

Some university students who maintain their cultural dialect, language, and accent are viewed as "stupid," 'inferior' or 'rudimentary' by their peers. In addition, most of the studies on code-switching concentrated on the degrees, nature, people, groups, patterns of occurrence, attitude to, functions, forms, causes of code-switching to draw conclusions on the linguistic aspects of the alternation. However, very few look at code-switching as a way out for making-meaning. This study addresses part of this problem by investigating the influences of status, gender, age, level of education, location, and domains of discourse, pragmatics, meaning making, language use and nature of alternation amongst bilingual university students and students of English language and any other language of the selected case study.

Review of Related Literature: Socio-semantics

The concept "socio" is seen as a prefix to a content concept, although, in this review, it is seen as a combining form that denotes social or the society meaning of language use. A combining form of meaning, "social", "sociological", "society", etc, in the context of the review, "socio-semantics"; where social, societal (group, community, common, public, collective etc) and sociological usage of language meaning meets. The major and recent expansion of various socio-semantic communities of bilinguals proves that code-switching has

been supported by a wide range of groups (age, status, culture, education etc.). Many of these are entirely unique and have simultaneously led to the availability of large amounts of detailed data on the users' choices of codes to express meaning in whatever context. Little or no review has been done in the area of "socio-semantics", although, some works could amply be related to the concept; where Jay Lemke reviewing Hasan's (2009) book on "Semantic Variation", stated that, adults and young children of different class families frame questions and answers, commands and requests, and grounds and reasons in casual conversation and in normal (formal) settings; in other words, they choose predominant codes in their repertoire that are used in whatever context or situation (even in formal settings).van Leeuwen's (1996) review on socio-semantics deals with options for representing social actors, with specific attention paid to discourse; his proposed analytical category is sociological rather than linguistic, although, he asserts that, "there is no neat fit between sociological and linguistic categories" (van Leeuwen 1996:33 cited in Reza et al, 2012).

Van Leeuwen's socio-semantic approach was to describe the social and semantic features of representation of the social actors in a social interaction, although basically in the studies within Critical Discourse Analysis (CDA), the framework has been used to analyse media discourses (van Leeuwen, 2008 cited in Reza et al, 2012), nonetheless, we appreciate that his review pointed out groups or associations, with a chosen code for their interactions. Therefore, we also know that sociolinguistics studies the effects of any and all aspects of society, including cultural norms, expectations, context and the effects of language use on society. This review on social/societal semantics as a branch of the field of linguistics, that investigates human practices in specific social and cultural circumstances, tries to explain meaning-making both as a societal and social practice or integration on language usage and the effects on the learners or speakers of Nigeria's 'lingua franca'.

Language makes it possible for one to communicate one's thought, as languages, dialects, groups codes are increasingly coming into contact as a result of the impact of scientific and technological developments; it is imperative for thoughts to be wider than one's cultural setting. The domain of discourse determines the register employed in each domain.

Appel and Muysken (1989) function model observes that, switching can serve the referential function. According to them, topics related to switching may be thought of as serving the referential function of language. Alfonzetti (2002) also states that, "speakers switch to the code they consider more appropriate for a given topic" (p.197), she adds that although this sometimes happens, it simply fails to account for many other contextual implications of the occurrence (effective meaning-making), and that it is a contextualization cue used to signal a change in the conversational context. Holmes (1992) further reiterates that, there are domains of language use that induce language choice for situational meaning-making.

Concept of Code-Switching

Gardner-Chloros (2009) defines code-switching as "the use of several languages or dialects in the same conversation or sentence by a bilingual person". According to her, code-switching in this sense means switching between different languages or language varieties by bilinguals and multilinguals in the course of a single conversation. Through code-switching in linguistics many bilinguals will utilize their ability to shift from one language to another to communicate with others in an unchanged setting and usually within the same utterance (Bullock & Toribio, 2009) not necessarily minding if the listener understands the intended meaning. The Nigerian university is a community where this occurs as a result of various convergences of many ethnic groups.

The interactive significance of code-switching between bilingual speakers cannot be overstated, even though, the outcomes of surveys show that it is conversational strategies generally used by bilinguals to efficiently share social and communicative significances. Inuwa (2014) asserted that "Hausa bilinguals alternate between the two languages to quote a speech made by someone without dropping the intended meaning" (8). They use code switching strategy to address different audiences within the same utterance, and sometimes make an objective comment. On the other hand, whenever the bilinguals lack a linguistic element in one language, they have an option of using its equivalent in the other code. The bilinguals sometimes use code switching to avoid message ambiguity by uttering the same statement in another language to clarify the message to the anticipated listeners. They, however, switch between languages when they intend to indicate a precise point, or at times to display exclamations such as anger or surprise. Same members belonging to a certain language group or ethnicity, such as students/friends normally use code switching to share the individuality that binds them together.

Code-switching occurs when the speakers involved in a conversation use both languages together to the extent that they change from one language to the other in the course of a single utterance (Wardhaugh 1986), although, this could be seen as inappropriate for communities like Nigeria, if the speaker or listener is not a competent speaker of one of the languages in the conversation. Poplack and Meechan (1995:200) emphasize the fact that, in code-switching the languages are clearly separate from each other, when it involves two competent bilinguals of the languages, each of which is internally consistent with the morphological and syntactic (and optionally, phonological) rules of its language, which means, the use of code-switching by people is dependent on their linguistic acquisition level, and the types of socialization (context) and interaction (situation) they are involved in but also being able to keep both languages apart where the lingua franca is required.

Code

Romaine (1988:48) opines that "code is a term which refers to a variety". A code may then be an idiolect, dialect, sociolect, register or language. A speaker has a linguistic repertoire that consists of a variety of codes. In a monolingual situation, the use of different codes depends on the variability of language, while in a bilingual or multilingual society, it is normal for the people to be in a situation where a choice between two or more codes (languages) has to be made. In such a situation, bilinguals may want to consider for example, who speaks to them, in which language or variety, and when or where the conversation takes place (Fishman, 1965). Hymes (1964) suggests eight factors that bilingual, multilingual and monolingual speakers do consider when choosing a code to express meaning. The factors are speaking (which stands for "setting and scene" in form of location, occasions and natural situation), participants (which stands for people—users or speakers), ends (which could be goals or purposes), act sequence (that is order of speech, conversation, narrative, etc.), key (in form of spirit, manner and feelings), instrumentalities (like registers and forms of the speech), norms of interactions (which is the contextual custom in using the codes), and genre (like lecture, poem, proverb forms, etc.).

Code-Switching and Code-Mixing in the Nigerian Context

Nigeria today has more than five hundred (500) languages and over one thousand dialects. This has given room for the growth of bilingual or multilingual speakers who use English language in the country. Therefore, code-switching occurs frequently in almost all conversations, even in professional settings. With multiple languages in the country, the possibility of mixing English with ethnic languages is inevitable. The concept of "code-mixing" is used to refer to a more general form of language contact that may include cases of code-switching and other forms of contacts. The emphasis here is on the grammatical features and lexical items from two languages in a sentence (Muysken, 2000).

Code-mixing is the change from one language to another within the same utterance or in the same oral/written text. Some sociolinguists differentiate between code-switching and code-mixing while others simply refer to them both as code-switching. Hudson (2001) separates code-switching from code-mixing by defining code-mixing as alternations that happen when a fluent bilingual talking to another fluent bilingual change codes without any change at all in the situation. The other assertion is that, code-switching has become a common term for alternate use of two or more languages, or varieties of language or even speech styles, while Gal in (Wardough, 1986:103) points out that, code-switching is seen as a conversational strategy used to establish, cross or destroy group boundaries, in order to create, evoke or change interpersonal relations with their rights and obligations.

Essentially, it has been difficult to differentiate between code-mixing and code-switching by scholars; however, they have enabled one to see some indicators related to the differences of these two sociolinguistic terms. First, code-mixing bilingual speakers seem to apply some words or phrases from foreign languages while the other language (code) functions as the base language. Secondly, the assumptions that bilingual speakers mix codes when there is no topic that changes, neither does the situation (Gumperz, 1986). A different view proposes that if it involves changing into a foreign clause or sentence, it should be defined as code-switching but if it involves the use of foreign phrases or group of words, it is identified as code-mixing. Poemer (2011) adds that the use of code-switching or code-mixing is determined by the formality of the situation, while code-mixing is found in the less formal situation, code-switching possibly occurs in a formal one depending on the accepted code.

Code-Switching in Nigerian Universities

In Nigerian university communities, speakers use code-switching as a way of communicating their ethnicity among others. They work towards declaring an ethnic identity as they demonstrate acceptable ethnic group markers to the others (Trimble, et al 2005). Babalola and Taiwo (2009) gave a good example of this assertion by some Nigerian artistes who try to relate with their roots. Such artistes have consistently strived to make creative use of their indigenous languages in their songs, although most songs are written in English language. Therefore, in relating language with one's mental image and the importance of identity, an artiste could connect with people from his own background. Nigerians listeners within the university community in-turn use the ability to relate with social groups who understand the usage of words or sentences code-switched in Nigerian music. Artistes' use of code-switching in music gives second language learners and bilinguals the opportunity to proclaim their ethnicity and identity. And because of this, there is huge pride of users, who tend to ignore the diminishing level of their ability to keep the languages apart in formal situations for a meaningful expression.

Theoretical Framework

The theoretical framework adopted for this paper is 'Conceptual Analysis' as explained by Lyons (1977:109) and Saeed (2003: 34-46, 266-76) Fishman's (1972) "Domain and Topics" analysis and Labov's (2006) "Quantitative Paradigm" analysis as an eclectic study. The term conceptualism is used to refer to any theory of Semantics that defines the meaning of a word or expression, a concept associated within the mind of the speaker and listeners. This framework is supported by numerous hypotheses of the theories of meaning such as code-switching, interactional sociolinguistics, the Semantic Model of Conversational Code-switching by Gumperz further modified by Auer (1984) and the "Ideational Theory of Meaning" developed by Locke (1975) cited in (Brown et al, 2010). The theory explains that the meaning attached to words can be separated from the words themselves; that is to say, meaning originates in the mind in the form of ideas. Therefore, language is a mechanism for expressing thoughts and thought is viewed as a succession of conscious ideas while words or codes are just sensible signs for the convenience of interaction. The ideational theory is perceived to be conceptual or vague because of its dependence on mental images for decoding the meaning of words. Locke also calls this a mentalist theory of meaning; it is because the meaning of a word is the mental image or idea of the word or expression generated in the mind of the speaker or hearer.

Research Methodology

The research design for this paper combines aspects of qualitative and quantitative analysis; this mixed method could add technical hitches to the research design and use the advantages of both designs as well (Creswell, 2008), nevertheless, it enhanced the collection and analysis of data. The components of design allows the researcher to rely on codes/varieties and languages/dialects used in code-switching with English Language by students of the University of Agriculture Makurdi and Benue State University in relation to their expression of meaning as related to this study of 'socio-semantics' in code-switching (sociolinguistics). The qualitative research design is constructed with the types of knowledge intended to form a better argument within the framework and theoretical concepts of the thematic; thereby bringing an understanding and a perspective towards semantics, sociolinguistics and linguistics at large. Two hundred and fifty students (250) were selected randomly. The data collected was stratified along the domains of language use and the technique was adopted in selecting students from natural contexts of language use that formed the sample for the study.

Data Analysis

The data presented below is order to determine the socio-semantic effects of social meanings on the conventional language meaning of code-switching, illustrate code-switching prominence among university students and show the socio-semantic codes, situation/context used for interactions and the implications of code-switching in Nigerian universities, determine the frequency and rate of code-switching among university students, illustrate if code-switching among students in the selected case study is proficiency-driven or deficiency-driven and exemplify the influence of domains of discourse, pragmatics, language use, meaning-making and nature of language alternation on students. A summary of the findings are presented in Twenty One (21) tables below for easy comprehension aimed at drawing a valid conclusion.

The results showed that 76.9% male students responded to the questionnaires, while 23.1% are females. The result reveals that there is no significant influence of gender on code-switching, though male students code-switch more frequently than their female counterparts. Note that, the paper's focus is not on the gender differentiation of the use of code-switching but the general usage by students; although, the observations and recording, male students code-switch often as a result of their peer group association.

The table above shows that twenty six (26) students representing 10.9% fall between 31-35 age bracket, fifty five respondents between the ages of 18-24, while one hundred and fifty seven representing 66.0% are between the ages of 25-30 years. This indicates that there are students who are older and probably more experienced and those who are younger and are possibly bilingual speakers.

In analysing the Level of Education influence on Code-switching, it is not always easy to categorize individuals into classes, because such categorizations may not be very adequate for empirical research. Chieni (2001) suggests that there are different scales used to classify people within a social system such as; occupation, education, income, where people live and so on. The assumption is that each group's level of education (100 Level to 600 Level and Masters Level) is likely to affect its language use and the representation in the Table 3 above shows that all the respondents were either in 400 Level or above and do code-switch.

The table shows that a total of ninety five students responded from the University of Agriculture with 39.9%, while 60.1% of the respondents are from the Benue State University.

Domain of Discourse on Code-Switching Meaningfully

In order to understand that nature of code-switching by students, topics and context of the conversation, the interlocutors involved, location or place, all summed up the response presented in the tables below in order

to identify the influence of domains of discourse, pragmatics, language use, meaning-making and nature of language alternation on students? Questions were posed to students in the one of the data collection methods; questionnaires (see appendix 1).

The table indicates a greater percentage of respondents switch in a conversation with parents at home. One hundred and six one (161) summing up 67.6% of the total respondents agreed they "often" or "most often" code-switch when discussing with parents at home, in other words, parents also condole Nigerian languages with their children more than the standard English language for relation, although, this is as a result of the speakers' repertoire competency.

This table indicates the influence of Nigerian languages in this domain of discourse, a total of 70.1% of the respondents said they either 'seldom', 'often' or 'most often' code-switch in this domain of discourse of academic debates; a formal setting that requires all students to be able to interact using the Standard English language.

Domain of Pragmatics on Code-switching

Domain of Pragmatics on code-switching basically deals with the standpoint of 'language use' and 'context of usage'. This section focuses on the pragmatics of 'inter-languages' (English usage and Nigerian ethnic languages) and the context to which BSU, UAM students relate, a focus which is justified by the growing importance of English as a global lingua franca.

Sixty eight respondents representing 28.6% admit that they do not code-switch in order to harmonize with speakers of the same ethnic group, 8.0% 'seldom', 44.5% 'often' and 18.9% 'most often' code-switch in this domain of harmonization of language.

The table shows that a total 95.8% of the respondents either "seldom", "often" or "most often" code-switch in this domain of pragmatics, since the context is formal and the domain indicates it's an academic discussion, only 4.2% of the respondents state that they do not switch to other languages in this domain of discourse when talking about academic issues with course mates in the classroom.

Domains of "Language Use" on Code-Switching

Domains of "language use" was first proposed by Schmidt-Rohr in 1932, and later developed by Fishman; based on Fishman (1972:20) as cited in Romaine (1988), "domain is a socio-cultural construct abstracted from topics of communication, relationship between communicators, and locales of communication, in accord with the institution of a society and the area of activity of speech community in such a way that individual behaviour and social patterns can be distinguished from each other and yet related to each other".

The table indicates that 66.0% of the total respondents speak two Nigerian languages, while 34.0% speak three Nigerian languages, in other words, students in these institutions are either monolingual or multilingual speakers of some Nigerian languages.

A total of 63.4% of the respondents indicated that they are L1 speakers of the Nigerian languages they speak, 10.9% indicated same as their second languages; while 25.6% agreed they speak both languages. 60.4% of the total respondents chose a Nigerian language before English as their languages of thoughts in school, social gatherings and at home. 39.5% indicated English language as their only code for thoughts in whatever context.

The language of communication among the students in the study area shows that Nigerian languages are the first option, and 32.3% of the total respondents indicate Tiv, Idoma, Igala, and Pidgin with English as their language of communication with classmates, while 67.6% indicated they use English language for communicating with classmates.

The table indicates that fifty one respondents (51) representing 21.4% code-switch for an hour daily, while 23.1% for six hours daily and 23.1% indicate they code-switch twenty four hours, seven days of the week (in other words, all days of their lives). Therefore, long term code-switching influences the speaker or the user of Nigerian languages against their use of English language.

Domain of Meaning-Making on Students' Language Use

Semantics is a term that refers to how meaning is assigned in language while a domain is essentially a specific place or territory. A semantic domain is a specific place that shares a set of meanings, or a language that holds its meaning, within the given context of the place. Harriet Ottenheimer a specialist in Linguistic Anthropology defines a semantic domain as a "specific area of cultural emphasis" (Ottenheimer, 2006).

This table presents data based on previous tables and with focus on the preference given to Nigerian languages over English language in order to make-meaning in a conversation, and 70.2% of the total respondents said they prefer Nigerian languages to make sense because it is "easily understood", 17.6% said "explanation is easy", "26.5% admit "lexical items are defined easily", "10.5% maintained "interpretation is done among people effortlessly", "6.7% said "there are better choice of diction than English language words", 29.8% did not respond to this question.

Students' Nature of Code-switching (Language Alternation) in Nigerian Universities

Language alternation describes the alternating use of two recognizable grammatical systems; two "languages" in some sense of that word. Language alternation concerns linguistic form, while code-switching concerns the contextualization of communication. In order to understand students' nature of code-switching, the need for their opinion was requested, with and open ended section of the questionnaire.

The table presents students' responses on reasons why the use of code-switching has affected effective communication with non-users, and 37.4% said "first language speakers find it difficult to be fluent and proficient", 37.4% stated that, "second language speakers find it difficult to speak their mother tongues

fluently and proficiently", and 23.5% also said, "there is conflict of choice on the use of semantics and the environment in which it would be spoken".

Motive-Determination Interview

The interview is carried out much later after the initial conversation (observational) to determine from the respondents whether the meanings and switches in their utterances were done as a result of bilingual proficiency or deficiency. Below is a presentation of data collected on fifty (50) interviewees, where twenty (20) questions were asked.

Discussion

Nigeria is a multilingual society with diverse cultures and languages, despite the dominance of English as the language of wider communication nationally and globally, it is classified as disrespectful in some quarters for a young person to communicate in English with an elderly person; this notion encourages the constant usage of speakers' mother tongue, given that, speaking the mother tongue serves as a polite technique, which however decreases the users' performance and competence in the country's lingua franca. The researcher agrees with Oseghale (2012) that, "...scholars of semantics are of the opinion that since English is spoken in Nigeria as a second language; socio-cultural variables are bound to influence the variety of English spoken by Nigerians". In circumstances like this (a multilingual national as Nigeria, with individuals proud of their mother tongue), a larger percentage of the Nigerian populace would prefer using their mother tongue in order to communicate meaningfully. According to the analysis, the connotation is that there is greater predisposition to code-switch in the urban areas than in the rural settings; the rural competence influences the standard conventional and official language in the urban areas. Below is a comprehensive discussion of the findings of the analysis:

Analysis of data on the psycho-physical variables shows that gender, age, level of education has no significant influence on code-switching among students in the institutions, although the random distribution and response on questionnaire shows that, male respondents are more than the female. Meanwhile results on age differ from McClure's (1977) assertion, that age is an essential variable that influences language alternation. Likewise, results on level of education corroborates Hoffman's (1991) opinion that, switching is a by-product of education, in other words, one's level of education does not influence code-switching, although to a degree, bilingual speakers would influence the switch. In this case, it was not as a result of the speakers' competency of the Nigerian languages and English language, but that; speakers are incompetent users of English language, likewise level of education does not limit individuals' code-switching. On the other hand, location has a significant influence on switching between Nigerian languages and English language within the university communities. This affirms Romaine's (2000) opinion that, because there is a convergence of different ethnic groups in the urban areas, there is the tendency for code-switching to be used functionally.

The analysis shows that, domains of discourse (registers employed in a conversation, codes for a topic, language choice) and pragmatics (language use and context of usage), language use (languages in a users' repertoire, topics and relationships between communicators) and meaning-making (meaning assigned on a code for a specific territory of usage) has a significant impact on the Nigerian university students in the study area. This indicates that, topics, situations, settings/location, context of usage does not necessarily limit students from choosing their competent or proficient code for interactions, and in this case, we found that, the lingua franca is not the first choice of code in their repertoire to interact. This finding agrees with the observation of Alfonzetti (2002) that, speakers switch to the code they consider more appropriate for a given topic and/context; showing an extensive level of switching both in formal and informal settings while 'discussing academic issues with teachers' and 'academic issues with course mates in classroom', 'academic issues with school administrators', 'during academic debates with fellow students', family discussion, friends and social gatherings' conversations etc.

Based on the data collected, it was observed undisputable that, students find it almost impossible to make meaningful conversation in their spoken English language, given the analysis reveals that 67.6% of the respondents agreed they use their Nigerian languages to make meaning, and when asked why, 44.5% said it is because of their level of "proficiency in Nigerian languages is better than that of English language", (in other words, they are competent speakers of their languages than that of English language), while 23.1% declared that, "they have more lexical items of their proficient language in their repertoire". The long term code-switching user has high influence on the speaker or the user of Nigerian languages who is expected to use English language in formal settings, indications show that, the duration respondents spent speaking and thinking in any of the Nigerian languages in their repertoire is high with 67.6% of the respondents affirming "they use languages or dialects to speak or think at least 1hour, 6hours or 24hours 7days a week".

Students in these institutions prefer Nigerian languages over English language in order to make-meaning in a conversation, 70.2% of the respondents said they prefer Nigerian languages, stating clearly that, it is "easily understood", 17.6% "explanation is easy", 26.5% "Nigerian language lexical items are defined easily", 10.5% "language interpretation is done among people at ease", other respondents argue that, "there are better choice of diction than English language words". The analysis further reveals the implication of usage of Nigerian languages and Standard English language when writing in whatever context, no matter the requirement, 46.2% of the total respondents agrees it has a negative effect on their usage of English language. Respondent further indicate that the switch between Nigerian languages and Standard English language has a significant influence on students of English language, 58.4% said it is has a "Very Negative effect", while 22.3% said the usage has "Negative" effect on university learners of "English language".

Analysis on the nature of students' code-switching among Nigerian university students and students of English Language (in particular) indicates that 75.2% of the total respondents state they "most often", "often" and "seldom" code-switch to Nigerian languages to make meaningful conversation. The usage, language choice, creation of codes by groups or associations elaborates on social and societal meaning of either the choice of words and grammatical expression in whatever context or situations of usage. Having affected the standard usage of English language and students' meaningful expression, the outcome is that the Nigerian languages' conventional lexical items and meanings are altered by groups or association to suite their usage. The case study reveals that students encountered difficulties with the use of Standard English Language while interacting (both at formal and informal settings) and that listeners do not understand when they use the wrong choices of codes in a certain context. This reveals that, any meaningful conversation in Nigerian languages is based on the context of the groups or associations' networks, that relate and appeals to their local languages or dialects with the use of terms readily associated.

This paper has added a considerable value to the field of linguistics, semantics and sociolinguistics and the nature of English language use in Nigeria with particular emphases on the language use of Nigerian university students and meaning making. This paper highlighted the features and linguistics performance of university students, and a clear indication that Nigerian university students' code-switch inappropriately in order to express meaning including at formal settings or domains that requires standard usage of English Language. Amid this, the findings revealed that, the nature of code-switching, frequency of code-switching by students both at the formal/informal context, shows that, English language in Nigeria has little or no native speakers of Standard English language (Br.Eng). This paper has also added that considerable knowledge to our today's linguistic field, indicating that scholar, teachers, well-read bilinguals, linguists and professors of English language in Nigeria code-switch even with students within the academic environment, thereby given room to learners' frequent switch of codes both in formal and informal context, indicating that being a bilingual or a multilingual is no longer an just an ability but as a result, the inabilities of speakers standard English language users to fall back to their ethnic languages in order to express meaning.

Conclusion

The paper concludes that the socio-semantic impacts/effects of social usage have significant influence on the standard usage of English language among Nigerian university students as well as students of English language as a result of frequent usage of mother tongue or some other Nigerian language. The Nigerian languages, dialects, groups or associations' codes, students' mother tongue and second languages (not English language in this case but Nigerian languages), academic environment (classrooms and administrative offices), social gatherings within the academic environment, home, religious environments are all types of situation/context for code-switching in Nigerian universities. This implies that, the frequent switch in all these context/situations makes it almost difficult for students to keep informal and formal choice of language use apart. This was clearly revealed in the analysis, the frequency and rate of code-switching among university students is exceptionally high, because Nigerian university students' code-switching is proficiency-driven (with Nigerian languages) and deficiency-driven (with Standard English language).

The impact of the domains of discourse, pragmatics, language use, meaning-making and nature of language alternation on Nigerian students indicates that it is also almost impossible for speakers to choose the appropriate code for every context/situation in order to make meaningful expressions on topics or issues while interacting. The domain of language use of students indicates that, the socio-semantic (social in this case) impacts of social meanings of language use over the conventional language meaning is appreciated even among the elite. The influence of domains on students switching in the classrooms clearly shows users language preference (based on student repertoire language proficiency) against the nation's lingua franca.

The socio-semantic (social, societal) implication of code-switching against the conventional language indicates that, societal or conventional lexical and sentential meaning of language is lost (based on the users and the context of usage), while those of the students (social usage) is adopted and accepted. The review indicating that, meaning is expressed most often when using more than one language during interactions and the elaboration on the socio-semantics of students' language use in whatever context/situation affects the standard expression of English language used for a meaningful expression.
